2024 Annual Meeting: Memories of MetroCare

After brief network business updates, Dr. Carter Towne, Bill Breen, and Donna Abney reminisced about the founding of MetroCare and HealthChoice and their relationships with MLH with attendees that included Dr. Jim West, Maurice Elliot, Gary Shorb, Chuck Utterback, and the daughters of Dr. Richard Raines.

Dr. Towne spoke of the early days and the pivotal role of Dr. Raines in founding MetroCare. Donna Abney spoke of the importance of the contracting work of MetroCare Physicians for LeBonheur and Methodist and area physicians, and Bill Breen spoke about the beginnings of HealthChoice as a healthcare contracting entity.

In the early 2000s, MetroCare and HealthChoice, along with Methodist Le Bonheur hospitals, grew our network to hold the contracts for 72% of the entire commercial book of business in the Memphis area. Click here for details/photos

Additionally, Dr. Towne served on the board of Methodist Le Bonheur Healthcare for 14 years, allowing him to build valuable relationships and important channels of information for both the hospital and area physicians, bolstering the role of MetroCare and HealthChoice in healthcare for our area.

For the last four years, Dr. Towne has been even more hands on with the work at MetroCare, incorporating the duties of a medical director with his board chair responsibilities. We appreciate and honor his long service and wish him well in his new life.
