#### 2025: New Fee Schedules and More

The Medicare Physician Fee Schedule s 2.83% physician reimbursement via conversion factor Physician pay rates from Medicare have dropped 33% in the last 20 years without consideration for increasing practice expenses over time. The proposed continuing resolution had mitigated the 2025 drop in large part by including a base fee schedule increase of 2.5%, but the last minute compromise on Dec 20, a temporary three-month fix that passed, did not include any revenue assistance at all. However, it did include an extension of the COVID PHE telehealth waivers that were slated to expire by January 1.

New codes for Advanced Primary Care Management were added to allow PCPs added revenue for managing complex and chronic problems across specialties, and a slight change to billing the G 2211 add on to E/M now allows it to be used with a 25 modifier when billed with any Medicare approved preventive service such as an AWV or vaccine. MetroCare is hosting brief lunchtime coding webinars on February 5 and 12 to discuss the proper use of these codes along with other 2025 fee schedule related coding changes. click here

The Medicare Prescription Payment Plan option allows Part D patients to spread out copays for expensive drugs with monthly payments to their Part D plan.
